### OFFICIAL RULES

**1. ELIGIBILITY:** The Chance to Win Tickets to Hubbard Digital Academy! Sweepstakes (“Sweepstakes”) is open to legal residents the 50 U.S. and D.C., ages 21 or older who reside in Minnesota, Wisconsin or Iowa. All directors, officers, and employees of Hubbard Digital Twin Cities, LLC d/b/a Hubbard Interactive (the “Sponsor”), and its parent company, subsidiaries, affiliates, advertising and promotion agencies (collectively, the “Promotion Parties”), and each of their immediate family members (spouses, parents, children and siblings, and their respective spouses) and/or those living in the same household of each, are not eligible to enter or win the Sweepstakes. Then, leave a review about our *The Social Feed Podcast* on iTunes for one (1) additional bonus entry into the random drawing (**Please Note:** you must provide your iTunes username on your initial entry form to be eligible for the bonus entry). **Limit:** one (1) regular and one (1) bonus entry per person during the entire Sweepstakes Period. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law.
